## Instructions for Authors

Scholars presenting papers at the annual meeting of the G.A.H. are invited to submit their papers to the *Journal*. The J.G.A.H. is a refereed publication. Not all papers submitted will be accepted, and it is not unusual for authors to be asked to make revisions. Submission of papers not presented at the annual convention is also welcomed.

**Submission:** Articles may be submitted throughout the year, but there is a deadline of one month after the meeting (usually about May 15) to be sure of inclusion in that annual volume. The initial submission should be four copies. To facilitate the peer review process, these should not have the author's name. (Please be sure to include name and address separately.) The copies, not submitted at the annual meeting, should be sent to the editor at the address below.

**Style:** Papers should be double-spaced throughout, and references should be done as end notes. The J.G.A.H. uses the *Chicago Manual of Style* and/or Kate Turabian, *A Manual for Writers* for citation, though with some variation (for instance only place and date of publication are required). Some sample notes are provided on the back of the page for your convenience. Notes should be numbered consecutively through the manuscript, and titles italicized (not underlined).

Final submission of articles that have been accepted for publication, if possible, should be on computer disk prepared with WordPerfect 5.0 or higher. (Authors using other word processors are asked to check with the editor as conversion to WordPerfect may be possible.) When typing the final version, please keep formatting as simple as possible. Use of delay or suppress commands may interfere with the formatting of the manuscript for the printer. Indenting should always be done with the tab or indent keys/commands not with the automatic first line indent or with the space bar. The program regards individual spaces as flexible for justification, which may change in preparation for printing. Do not use block protection. An author's inability to submit on disk will have no effect on acceptance of his/her essay for inclusion in the J.G.A.H.

## COPYRIGHT INFORMATION FOR AUTHORS AND RELEASE FORM

The U.S. copyright law effective January, 1978, requires explicit transfer of copy right from author to publisher (previously implicit in the submission of a manuscript) to enable the publisher to have consistent copyright protection and right to disseminate the author's work. Therefore, the following agreement, executed and signed by the author, is required with each manuscript.

If you wish your paper, abstract, or commentary to be considered for publication, fill in and sign this sheet and return it to the editor. (If you wish only the abstract of the paper to be published, mark out the words "article and" in the first sentence below, leaving on "The abstract entitled . . ." and mark out other instances of the word "article.")

### TRANSFER OF COPYRIGHT AGREEMENT

(Must be signed and returned to the J.G.A.H. editor before the manuscript can be considered for publication.)

If and when the article or abstract is accepted for publication, I, as author, hereby agree to transfer to the Georgia Association of Historians all rights under existing copyright laws except for the following:

1. The right to make further copies of the published article or abstract for use in classroom teaching;
2. The right to re-use all or part of this material in a compilation of my own works or in a textbook of which I am the author;
3. The right to make copies of the published article or abstract for internal distribution within the institution that employs me, or for other noncommercial, nonprofit purposes that do not affect the potential market for or value of the article.

I agree that copies made under these circumstances, including translations and adaptations, will carry the copyright notice that appeared in the original published work, the *Journal of the Georgia Association of Historians*. I further agree that all statements and opinions in my article and abstract are my own and are not necessarily shared by the G.A.H. or the editors of the *Journal*.
